<u>Cravath Partner Rowan Wilson Confirmed</u> as an Associate Judge of the New York State Court of Appeals

New York, February 6, 2017 – This afternoon, the New York State Senate announced the confirmation of Cravath, Swaine & Moore LLP partner Rowan D. Wilson to serve as an Associate Judge of the New York State Court of Appeals, the state's highest court. Judge Wilson was nominated by Governor Andrew M. Cuomo on January 15, 2017.

Judge Wilson joined Cravath in 1986 and became a partner 1992. He is highly regarded as one of the country's leading litigators in the area of complex litigation. In addition, as the partner responsible for overseeing the Firm's pro bono work, he has been a strong advocate for the expansion of civil rights. Upon his confirmation, Judge Wilson retired as a partner from Cravath.

"Rowan is an outstanding trial and appellate litigator, who will bring to New York's highest court extensive experience in complex commercial matters, coupled with a lifelong commitment to civil rights and social justice," said Cravath's Presiding Partner, Faiza J. Saeed. "He joins a long line of Cravath partners who have been called on for important public service roles throughout our history."

Throughout its 200-year history, Cravath has had a distinguished tradition of public service that began with one of the Firm's founders, William H. Seward. Stong (U.S. Bankruptcy Judge for the Eastern District of New York).

Judge Wilson received an A.B. *cum laude* from Harvard College in 1981 and a J.D. *cum laude* from Harvard Law School in 1984, where he was a member of the Civil Rights/Civil Liberties Law Review. After graduation, Judge Wilson served in a two-year clerkship with Hon. James R. Browning, Chief Judge of the U.S. Court of Appeals for the Ninth Circuit.
